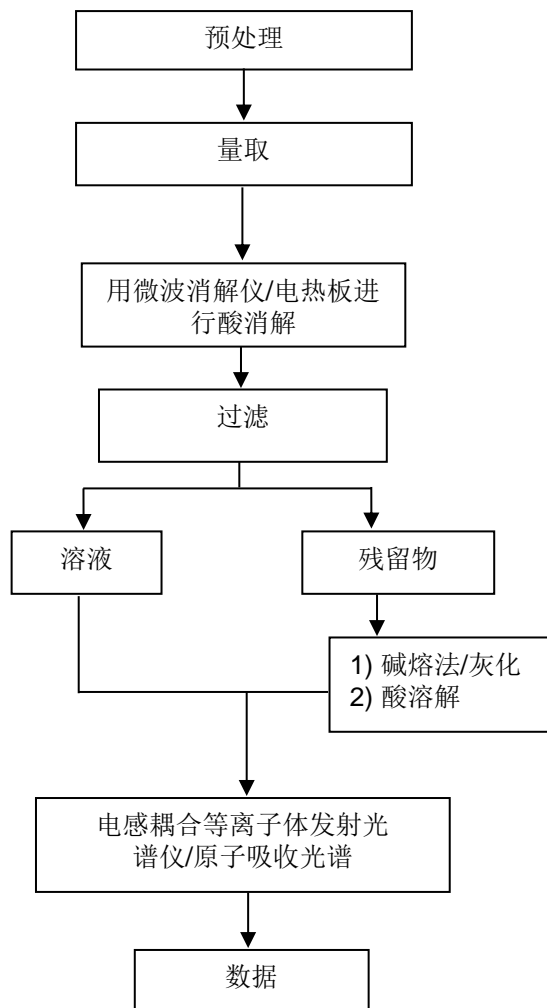

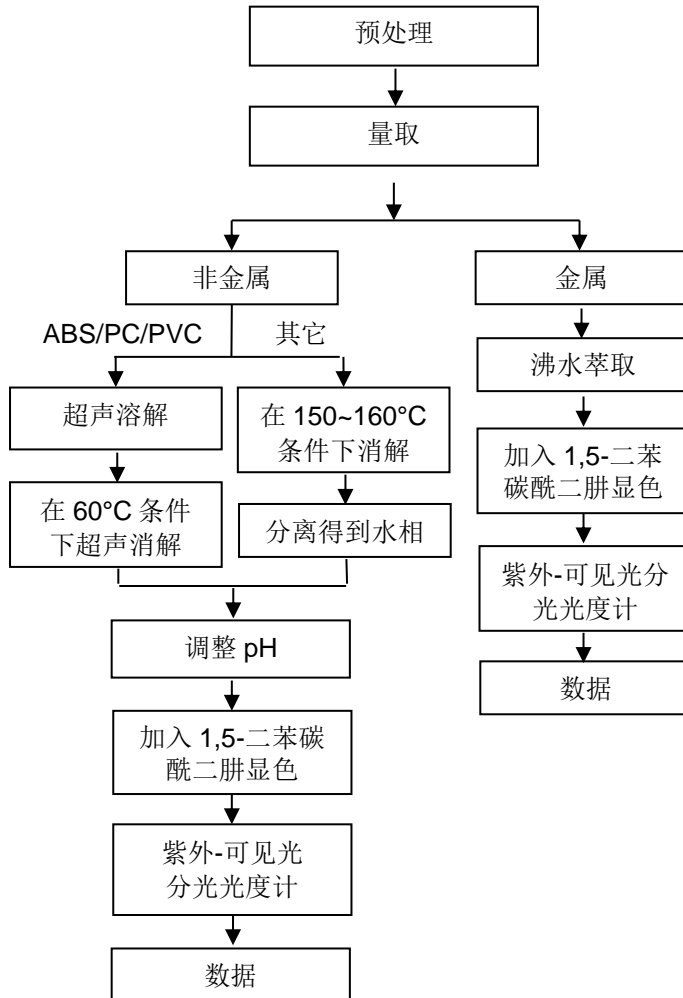

## 六价铬检测流程图



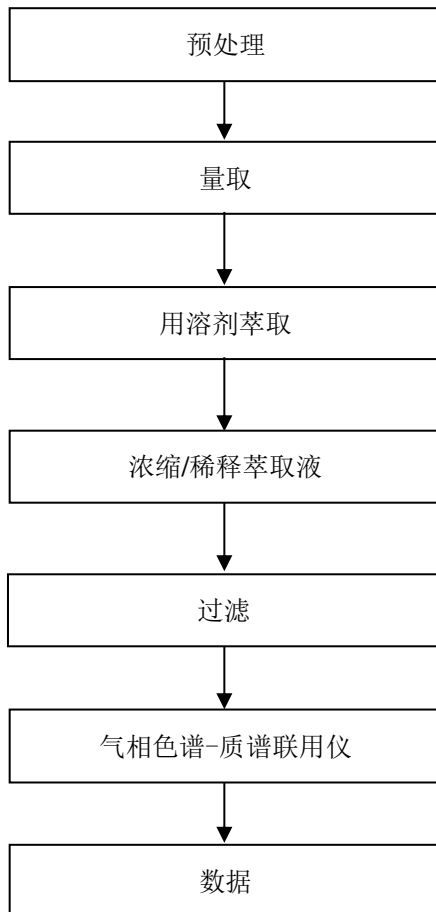

### PBBs/PBDEs 检测流程图



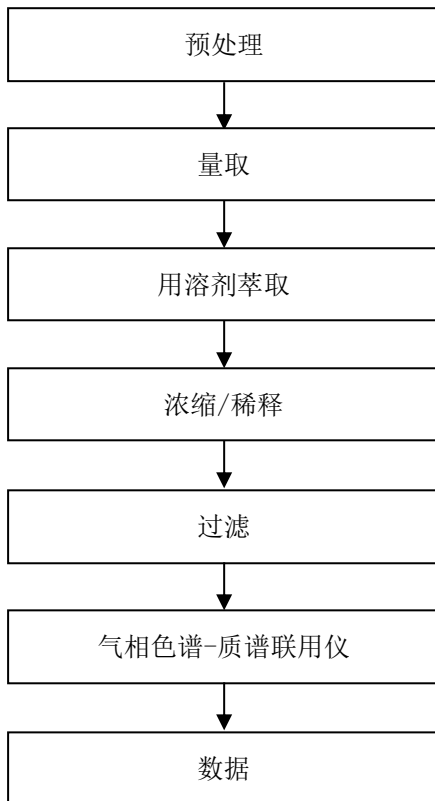

### Phthalates 检测流程图



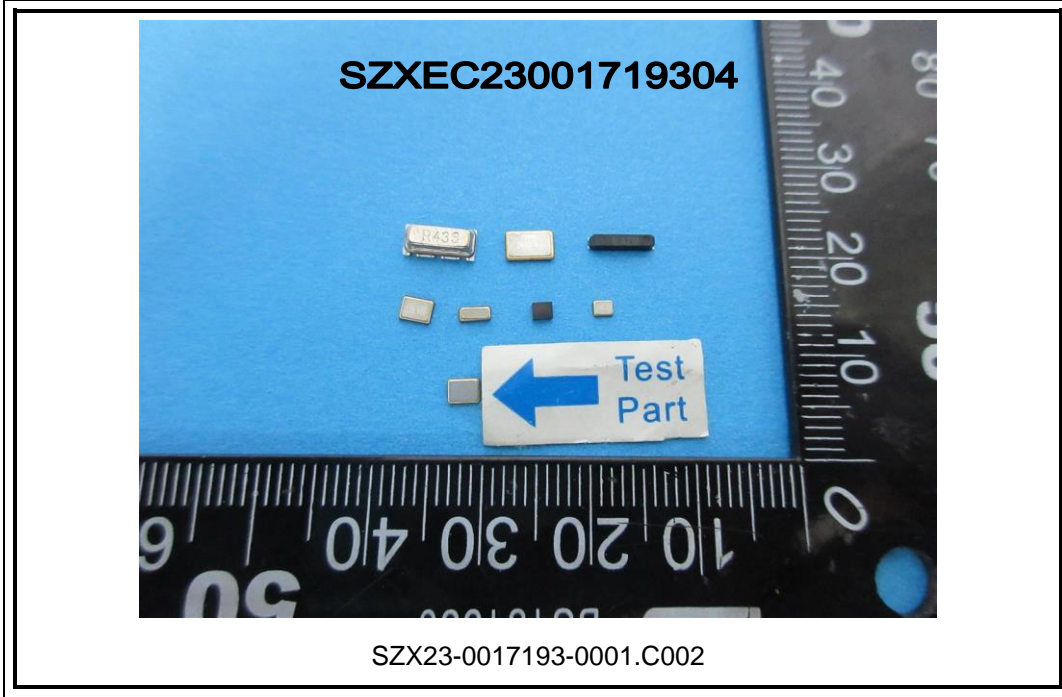
